## **Interagency Fire Program Management**

**NOTE:** For IFPM positions with multiple NWCG qualification pathways, qualifications cannot be exchanged between pathways. For Example: In order to qualify for a moderate complexity Unit Fire Program Manager position, applicants with only HEBM and RXB2 would not meet the requirements. Applicants who have HEBM and ICT3 would meet the minimum NWCG selective placement factors under qualification pathway # 2.

1. The National Fire Management Leadership (NFML) course will be assigned the M-582 course number and retitled: Fire Program Management – Leading Complex Programs. NFML and M-582 both meet the training requirement for these positions.
2. Local Fire Management Leadership (LFML) and M-581, Fire Program Management courses have been combined and will be delivered as M-581, Fire Program Management – An Overview. Completion of LFML, M-581, Fire Program Management, or M-581, Fire Program Management – An Overview meet the training requirement for this position.

The DOI Bureaus will administer the M-581 training requirement for Unit Fire Program Managers as a condition of employment required to be completed within one year of entry on duty. The USDA Forest Service will administer M-581 required as a condition of hire for all applicants.

3. Helibase Type 1 (HEB1) and Helibase Type 2 (HEB2) positions have been combined to Helibase Manager (HEBM) position. Incident qualification records in all systems have been updated to reflect this change.
